### **Notice – Public Comment Hearing for Cascadia Water’s Rate Case**

On February 29, 2024, Cascadia Water, LLC (Cascadia Water or the Company) filed for approval from the Washington Utilities and Transportation Commission (the Commission) to increase rates effective June 1, 2024. Cascadia Water later extended the effective date to July 1, 2024. On its June 27, 2024, Open Meeting, the Commission suspended the Company’s tariff revisions and set the rate case for adjudication. On September 26, 2024, Cascadia Water submitted testimony seeking to increase rates effective May 1, 2025. Listed at the end of this Notice are the proposed rates **for your system** and resulting average monthly bill impact from the September filing in this general rate case. Increased rates will reflect additional revenue of \$1,726,600, which is \$62,193 less than the additional revenue the Company sought in its February 29, 2024, filing.

#### **Purpose of General Rate Case**

The purpose of this filing is to recover costs associated with water service. Cascadia Water is seeking to recover costs in rates because current revenues are insufficient to cover the ongoing cost to provide service that is safe, adequate and efficient.

Since its prior general rate case, Cascadia Water has prudently managed its operating expenses. Many of these expenses have increased due to high inflation that is beyond the Company’s control. Cascadia Water has also made substantial system-wide investments and completed several key infrastructure projects that enhance service, for the benefit of its customers. The Company also is undertaking other key infrastructure projects that are yet to be completed.

The Commission has the authority to approve rates that may be higher or lower than Cascadia’s request. The Commission is examining the proposed rates; the examination can take up to 11 months from the Commission’s suspension of the Company’s tariff revisions.
